Any member who is 80 years old on January 1<sup>st</sup> and having been a member of the SLPVA for 15 years prior shall be known as an Elder Member with their annual dues waived.

Annual dues may be paid at any meeting of the SLPVA, by mail, or by payroll deduction each January. Members on payroll deduction will automatically receive their membership cards each January.
