Dear Medicare Supplement Retiree:

I am very pleased to announce that the City of St. Louis has approved the continuation of your Medicare Supplement Benefit Program with Amwins Group Benefits, Inc. as the plan administrator for the calendar year 2024. Your current level of benefits will remain the same in 2024. Your co-payments for Prescription Drug will also remain the same. There will be no "donut hole".

There will be a decrease of approximately 6.4% in spouse's and widow's monthly premiums from \$332.97 to \$311.59 that is effective January 1, 2024.

Police Division Retirees eligible for Medicare, need to enroll in Medicare parts A and B; then enrolled in the City PD Medicare Supplement Program. If you have a spouse/domestic partner who is not yet Medicare eligible age, and you wish to enroll your spouse/domestic partner in the Retiree Medical Program, you will be responsible for 100% of the cost of your spouse/domestic partner coverage. This information is indicated on the attached Retiree Enrollment Form.

The providers for your Medicare Supplement programs are the same as in 2023. Please note that the coverages for your Medical Supplement are bundled together and cannot be separated.

If you wish to change your coverage you must complete the enclosed enrollment form and return it to the City of St. Louis, Department of Personnel, Employee Benefits Section by November 17, 2023. You can email the completed form to CityEmployeeBenefits@stlouis-mo.gov.
