Minutes of the May 11, 2011, SLPVA Meeting

The 391st meeting (Spring Cook Out) of the St Louis Police Veterans' Association was called to order at 1145 AM by President George Ratermann. Chaplain Vincent Smugula led the members in an opening prayer and the Pledge of Allegiance.
